

## President's Report

7/8 Flights Grant – Submitted grant to NEMCF for the Fibar mulch for Flights. The NEMCF Board meets on 9/14/2021 to make their decision.

7/10 – Work bee at the ARA site.

7/13 DDA Meeting – Discussed the RRC, and the ACCOA Project. Sheila to contact NEMCOG to inquire as to how much they would charge to complete our RRC Dashboard Docs.

7/14 – Spoke with Dave Cook, regarding: ACCOA Ordinance, Our Place, and clean up at homes located on Traverse Bay Rd.

7/14 & 15 – Spoke with Troy regarding Travers Bay Rd. and Lincoln Outdoor Center clean-ups.

7/15 – spoke with Harry Harvey at the Building Department regarding the hole in the roof at Our Place and the process needed to have the building condemned. The Village needs to send a letter to the building department requesting an inspection under State Law. The Village is not required to notify the property owner, however, I feel strongly that we should (if the Council decides to proceed) send a registered or Certified copy of the request letter to the property owner.

7/15 – Spoke with Denise Cline regarding the completion of the RRC Document. The quote is \$5,000 to complete and NEMCOG will also incorporate our plan into the Counties' Economic Development Plan. While speaking with Denise, I asked about grants to remove condemned buildings. She indicated that there are grants available to do so, it will just depend on if we qualify.

7/15 – Spoke with Jamie at Stephenson & Company regarding submitting the application for the ARPA dollars. They will be sending us a bill for the actual time spent preparing and submitting.

7/18 Human Resources - had a phone call inquiring about the Maintenance Position.

7/21 ARPA – Worked with Linda, Marsha & Jamie @ Stephenson & Co. to complete the application. It was submitted on 7/22/2021. Stephenson & Co. will be sending bill for the time that Jamie spent on completing the documents and submitting them.

7/27 – Spoke with Billy Cordes regarding equipment purchases and MDNR reimbursable grant. We also spoke with regards to the fire/first responder's ability to service the proposed ACCOA building project.

7/27 – received e-mail from Topcon GPS regarding upgrading our system, which was purchased with the SAW Grant. I have replied, asking if there is a fee.

7/30, 31, & 8/1 – Fair registration.
